



Smart Time: Time Capture & Reporting Datasheet

Smart Time is an advanced time management platform designed for law, accounting and professional services firms. The platform uniquely supports time capture, time entry, reporting and mobile in one cohesive package.

It is also platform independent. You can run Smart Time on any device and install any combination of modules and platforms depending upon your firm's needs.

The *Time Capture* module goal is to help timekeepers accurately complete their timesheets by providing a daily journal that answers the question "What did I do today and is it billable?"

For timekeepers who must record what they did in six-minute increments, the time capture module gives them perfect recall at the moment they prepare their timesheets. It gives them a daily journal that tells them what they did, when they did it and how long it took. It enables them to find the small increments of time that usually are forgotten, and to correct underreported entries.

HOW DOES TIME CAPTURE WORK?

Smart Time polls your firm's systems and the user desktop to find information about every event that occurred throughout the timekeeper's day. It finds emails, calendared meetings, phone calls, mobile calls, documents, dictation, browsing and more. Next, event data is cross-referenced to assign client matter codes, while supplementary data is added to the event description to better jog the timekeeper's memory.

Users can access their data online or receive a nightly journal report.

A REVENUE GENERATOR

Because leaked time is so pervasive in firms that bill by the hour, plugging this leak can lead to significant gains in billable hours, and therefore, revenue. Smart Time not only supplements the timekeeper's memory, but its simple interface and intuitive design make timekeeping less painful, leading to higher rates of compliance.

Let's take a look at the potential revenue impact of implementing Smart Time. It's very reasonable to expect to find an additional 4 to 6 hours of leaked time per timekeeper per month.

Our research shows that Contemporaneous timekeepers leak 4 hours per month, and Reconstructionists typically leak 6 or more hours. For a firm with 100 timekeepers (averaging \$400/hour), closing the leak represents an additional \$200,000 per month, or \$2.4 million per year, in incremental time value.

Native applications are available for iOS, Android and Windows mobile devices.

Pre-built data connectors are available for Microsoft Exchange, Autonomy iManage, OpenText Docs, WorldDox, Netdocs, BlackBerry Enterprise Server, Nortel, Avaya, Mitel, Cisco, Lync Server, Android, iPhone, Interaction, Equitrac, Copitrak, nQueue Billback, BigHand, Winscribe, Summation, Concordance, Microsoft Office and Adobe applications.
